## Minutes of the Parish Council Meeting of Burton and Dalby Parish Council held on Wednesday 20<sup>th</sup> December 2023 in Great Dalby Village Hall at 7.00 pm

#### 102/23 Apologies for Absence

Apologies were received from Councillor Davies.

#### 103/23 To Receive Declarations of Interest in respect to items on the Agenda

There were no declarations of interest.

# 104/23 Agree and Sign Minutes of the Parish Council Meeting held on Wednesday 29<sup>th</sup> November 2023

It was resolved that the Minutes from the meeting held on Wednesday 29<sup>th</sup> November 2023 had been amended and these were duly signed by the Chairman.

# **105/23** Matters Arising from the Minutes of Parish Council Meeting held on Tuesday 31<sup>st</sup> October 2023

Following the presentation by Mr Duncan Forbes at the November meeting a revised report had been received. The Councillors agreed that they would discuss the report, draw conclusions and discuss in detail at a future meeting.

#### **106/23** Opportunity for County/Borough Councillors/members of the public to speak

There were a number of members of the public from the villages within the Parish were in attendance at the meeting in relation to **Agenda Item 107/23**. Borough Councillor Bob Child and County Councillor Joe Orson were also in attendance.

#### 107/23 MMDR January 2024 Road Closure

Both residents within the Parish and the Parish Council had been advised of the impending road closure at the beginning of December which was totally inadequate with residents believing that the timing of this had been done so that no-one would be available over the Christmas period. Residents raised a number of points including:

- When residents visited the public meeting at Parkside in March 2023 (open day) they were assured that there would be no road closures. Full closure of the A606 has never been discussed and the proposed diversion is too long.
- Concerns were raised over the vulnerability of residents in Burton Lazars with increased taxi fares, the loss of the RF1 bus service being suspended, the impact on refuse collections and the increased waiting times for emergency services. In addition, residents believed that the

local police had not been notified of the road closure and there were no traffic management plans in place. A resident advised that they had requested copies of the full risk assessments but, at the time of the Parish Council meeting, these had not been forth-coming.

• A representative from Burton Lazars Village Hall advised that to date the village hall had lost approximately £2,000.00 in revenue for the month of January 2024.

In summary, residents believed that there had been a lack of communication from LCC or anyone else to the community and the Parish Council. Any communication had been late, minimal and ambiguous. Lack of consideration has been given to the proposed local routes that will be used. Residents want to see LCC come up with another set of proposals and have to instruct Galiford Try. There is no evidence of a contingency plan in place if the road works over run.

It was proposed by Councillor Ingram, seconded by Councillor Blewett that County Councillor Joe Orson calls an emergency meeting on Thursday 21<sup>st</sup> December 2023 at Burton Lazars Village with representatives from LCC Highways, MMDR representatives, Galliford Try, Parish Councillors and Members of the Public.

#### **108/23** Melton Local Plan Update – Issues and Options Regulation 18 Consultation Notification

Councillor Wilkinson had send to Councillors a proposed response advising that all questions have a response. It was proposed by Councillor Johnson and seconded by Councillor Blewett that any responses to comments are via the Planning Sub-group to Councillor Wilkinson who will then submit the Parish Council's response.

#### 109/23 Street-Lighting within the Parish

Councillor Wilkinson requested that, due to the increasing charges for our street lighting, the Parish Council obtains quotes for undertaking a review of the street lighting within the Parish to include repairs, replacements and energy costs.

#### 110/23 EV Charging Points within the Parish

Councillor Blewett advised that he had been in conversation with members of the Village Hall who were in favour of this initiative being pursued by the Parish Council. Councillor Wilkinson advised that he had made contact with Tilton on the Hill who has 4 charge points at their Village Hall. Councillors agreed that having a charge point(s) at Burton Lazars Village Hall would be an asset and Councillor Watson agreed to contact the pub in Great Dalby to enquire if they may be interested in have a charge point(s) in their car park. A letter will be sent, in due course, to the village hall committee at Burton Lazars.

#### 111/23 Ernest Cook Trust – Update

Councillor Ingram advised that he had a good meeting with representatives of the Trust who will offer their support to the Parish Council on future projects. Regular communications will be maintained by the Trust and the Parish Council.

#### 112/23 Project Planning

Councillor Ingram advised that as the Parish Council was planning for a number of projects that each of these projects should have a number of councillors allocated to them. This will be an Agenda item for the January 2024 meeting.

### 113/23 QR Codes

Councillor Johnson advised that she had been in contact with DSCM in Sileby and had agreed to visit them in the New Year to discuss the Parish Council's requirements.
