#### 093/22 Former Site, Sandy Lane, Melton Mowbray - Update

Following a meeting at MBC on Monday 27<sup>th</sup> February prior to the Parish Council meeting Councillor Wilkinson had sent to Councillors for consideration a Nissan Hut Position Statement. It was proposed by Councillor Blewett and seconded by Councillor Watson that the statement be sent by the Clerk tomorrow to Richard Redford and Louise Parker at Melton Borough Council and Lee Harris at Springbourne Homes.

#### 094/22 Review Progress with the Neighbourhood Plan - Update

Melton Borough Council has confirmed that the Neighbourhood Plan status is 'MADE'. Councillor Wilkinson advised the Parish Council to retain its licence with Parish On-line.

#### 095/22 Village Funding Requests – King Charles III Coronation Activities

Prior to the meeting the Clerk had circulated to Councillors the requests that had been received for funding towards village activities. All requests for contributions were 50% of the total cost of hosting the events. The remaining monies would be generated from ticket sales.

It was proposed by Councillor Ingram and seconded by Councillor Watson that the £100.00 requested towards the Coronation Quiz being organised by Great Dalby Pre-school be awarded.

It was proposed by Councillor Ingram and seconded by Councillor Wilkinson that the £1,000.00 requested towards the Family Picnic and evening event in Great Dalby be awarded with the proviso that 10 places at this event would be made available to residents in Little Dalby.

It was proposed by Councillor Ingram and seconded by Councillor Blewett that the £2,000.00 requested towards the Coronation Celebration in Burton Lazars be awarded.

The Clerk will write to the organisers of the village events with the Parish Council's decision, reminding them that payment will only be made against receipts received and, where possible, the receipts should be made out to Burton and Dalby Parish Council. In addition, a request will be made that a Parish Councillor attends a meeting where preparations for the event are discussed.

#### 097/22 Parking in Great Dalby

Councillor Watson advised that motorists had been parking on grass verges at various locations in Great Dalby and that motorists who dropped off and collected their children from the school had been parking without consideration to local residents and respecting the green spaces within the village. Councillors agreed that a letter should be sent to the school. The Clerk was requested to draft a letter and to send it to Councillors Johnson and Watson for approval.

#### 098/22 Parish Council Elections – May 2023

The Clerk advised that upon receipt of the Candidate Nomination Packs that these would be distributed to Parish Councillors who wish to stand for election on Thursday 4<sup>th</sup> May. Councillors were reminded that their completed paperwork must be hand delivered to Melton Borough Council on Tuesday 4<sup>th</sup> April no later than 4.00 pm.

#### 099/22 Parish Councillors' Reports and Risk Assessments

Councillor Wilkinson advised that he will liaise with Neal Edwards regarding the traffic survey work to be undertaken on behalf of the Parish Council.

Councillor Johnson advised that the bench opposite the Brook in Great Dalby had now been renovated.

Councillor Blewett advised that following the road works in Burton Lazars the footpath up and down the hill on the same side as the Church was becoming dilapidated. The Clerk will report this to Highways.

Councillor Ingram advised that Gallifords were holding a 'Meet the Contractor' event at Melton Borough Council on 17<sup>th</sup> and 18<sup>th</sup> March in relation to the North and East Melton Distributor Road. He will forward the communication to Councillors.

#### 100/22 Clerk's Report

The Clerk advised that the black bin had been delivered to Councillor Blewett to be erected in Burton Lazars. She advised that as there were already 'Dog Poo' bins in the villages and that the Parish Council had a couple of extra ones that could be placed in the villages, as required, then additional bins would not be ordered.

The Clerk advised that she had reviewed the Parish Council's Risk Assessment, Code of Conduct, Standing Orders and Financial Regulations and that no changes were required. It was proposed by Councillor Ingram and seconded by Councillor Blewett that the documents remain in their current format.
